Dr. Turner Nashe, Jr., is a serial entrepreneur and successful inventor specializing in innovative solutions that solve complex problems. With over 25 years of experience, he is a renowned business executive, state government administrator, software developer, and thought leader. These experiences have allowed Dr. Nashe to build a robust catalog of successful business ventures, proprietary inventions, and skillsets. His endeavors stem from a passion for problem-solving through innovation, which enhances lives and communities.

As an expert in developing cutting-edge solutions, Dr. Nashe has been selected by Fortune 500 companies, technology start-up firms, and government entities to advise, develop, and implement innovative solutions to address emerging industry trends. He served as an Executive Vice President of GTL, where he grew program participation by 200% YOY between 2017 and 2020.

He combined his entrepreneurial and technological savvy to develop proprietary software and business solutions, which rapidly and effectively meet industry needs. These solutions enable businesses to remain open during the pandemic.

Dr. Nashe currently maintains leadership roles in several companies he founded. He also serves as an advisor and investor for a software investment group that provides code and software support to over 20 start-ups. Dr. Nashe currently serves on the Board of Directors for the Nashville Entrepreneur Center and the Community Foundation of Middle Tennessee. His previous board memberships include Building Entrepreneurs for Success in Tennessee (BEST), 100 Black Men of Middle Tennessee, and the ScoutReach Program with the Boy Scouts of America.
